**LEGAL NOTICE**

IN EXERCISE of the powers conferred upon the Council of Ministers by Section 19(1) (a) of the East African Community Customs Management Act 2004, the Council of Ministers hereby amends the Second Schedule to the Act as follows:-

By inserting Paragraph 13 in PART A – PROHIBITED GOODS as follows:

*“Plastic articles of less than 30 microns for the conveyance or packing of goods.”*

This Notice shall come into force on the 1st day of July 2007.

**LEGAL NOTICE**

IN EXERCISE of the powers conferred upon the Council of Ministers by Section 114 (3) of the East African Community Customs Management Act 2004, the Council of Ministers has amended the Fifth Schedule of the Act as follows:-

1. Amendment of Paragraph 25 PART B - GENERAL EXEMPTIONS as amended by the Council of Ministers in the EAC Gazette Vol. AT 1 No 003 dated 31st June 2006

*“By inserting a full stop after the word “end” and deleting the words “wattage not exceeding 20 per bulb”*

2. Insertion of a Paragraph 28 of PART B – GENERAL EXEMPTIONS to provide as follows:

*“Items imported for use in licenced hospitals*

*Any of the following goods engraved or printed or marked with the hospital logo imported for use in licenced hospitals, as recommended by the Director of Medical Services subject to such conditions and limitations as the Commissioner may impose:*

*(a) shadow leas lamps for use in operating theatres*

*(b) blood freezers,*

*(c) kitchenware and equipment*

*(d) laundry equipment*

*(e) mattresses and linen*

*(f) bedside screens*

*(g) air conditioners*

*(h) uniforms for use by hospital staff*

*(i) water heating equipment*

*(j) trolleys and stretchers*

*(k) furniture”*
